# Directors' Explanatory Statement

#### Item 2 - Financial Reports

The Corporations Act 2001 (Cth) (Corporations Act) requires that members are provided with the opportunity to consider the annual Financial Report, Directors' Report and Auditor's Report every year. There is no requirement in either the Corporations Act or the People First Bank Constitution for members to approve these reports.

Members of People First Bank attending the AGM will be given a reasonable opportunity to ask questions and make comments on the reports at the AGM.





# Attending the AGM

#### Attend in person

Any People First Bank member can attend and participate in the AGM, as can anyone who has validly been appointed as a proxy by a People First Bank member. We recommend that you arrive at least 15 minutes before the scheduled start of the AGM. Seats may be limited.

#### Watch the live broadcast

Members who are unable to attend the AGM may watch the live AGM broadcast by logging onto the online platform at https://meetnow.global/MQ2RHAZ. We recommend members log onto the platform at least 15 minutes before the scheduled start of the AGM.

For members who joined with Heritage Bank, select 'Member', enter your voter ID (this can be found in the email or letter dispatched to you regarding the AGM) and select the country of your registered address.

For members who joined with People's Choice, select 'Member', enter your member number and select the country of your registered address. If in Australia, also enter your postcode. For overseas residents, enter your country code from the drop-down menu.

Further details regarding how to connect to the online platform and watch the live broadcast of the AGM can be found on our websites (peopleschoice.com.au/agm and heritage.com.au/agm).

## **Ask a Question**

Members of People First Bank attending the AGM will be provided with a reasonable opportunity to ask questions at the AGM.

Members are also welcome to provide questions in advance of the AGM. Proxy appointment forms can be used to submit questions in writing and may be returned to People First Bank at the time of a proxy appointment. See 'Appointing a Proxy' for details. The Chairman's and Chief Executive Officer's addresses for the AGM will be framed to cover as many of the key themes raised from questions submitted in advance of the AGM as possible.

Questions should relate to the performance of People First Bank or the items of business on the agenda. We are unable to answer questions involving individual accounts or individual account holders during the AGM. If you attend the AGM, employees will be available before and after the AGM to answer any questions of this nature.

# **Appointing a Proxy**

There are no items to be decided by a vote at the AGM. However, any member entitled to attend the AGM may appoint a proxy to attend the AGM on their behalf by lodging a proxy appointment form.

The proxy or proxies do not need to be a member of People First Bank. A member that is a body corporate may appoint a representative to attend the AGM in accordance with the Corporations Act.

A proxy may also ask questions. The proxy appointment form must be received no later than 3.00pm ACDT on Monday 24 November 2025.
