- 1. Information on how to enter the Promotion and the prizes form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- This promotion is being conducted by Heritage Bank and People's Choice Credit Union (People's Choice), trading names of Heritage and People's Choice Ltd ABN 11 087 651 125, AFSL and Australian Credit Licence 244310 of 400 Ruthven Street, Toowoomba QLD 4350, telephone 13 14 22.

Eligibility
