

Terms and Conditions – Adelaide Strikers BBL 2023- NOVA Deck Competition

1. Information on how to enter the promotion forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The company conducting this promotion is Heritage and People's Choice Limited ABN 11 087 651 125, trading as People's Choice Credit Union ("**People's Choice**", also referred to as the **promoter**) 50 Flinders Street, Adelaide SA 5000, Ph: 13 11 82.
3. To be eligible, an entrant must:
 - a. be over the age of 18,
 - b. visit People's Choice's Facebook page between 4:00pm (ACDT) Monday, 18 December 2023 and 4:00pm (ACDT) Wednesday, 20 December 2023 (ACDT),
 - c. like the Facebook post for the Adelaide Strikers – Nova Deck Competition which will be posted on or about at 4:00pm (ACDT) Monday, 18 December 2023, and

There are two (2) prizes, each of one (1) family pass into the Nova Deck at the final Adelaide Strikers home game, Tuesday 9th January 2024 (each prize valued at \$240.00 AU), to be awarded to two individual winners (total prize value of \$480.00 AU). Each Nova Deck Family Pass will include two adult tickets and two children's tickets to the **Nova Deck** at the final Adelaide Strikers home game (Match 31) on **Tuesday 9th January 2024 at Adelaide Oval**, War Memorial Dr, North Adelaide SA 5006.
6. Each Nova Deck Family Pass is valid for one single entry for two adults and two children. Adults and children must enter the gate and NOVA Deck at the same time in order to use the Family Pass. It is a condition of entry into this promotion that entrants must comply with all the conditions of use of the prize and conditions of entry to Adelaide Oval.
7. From all entries received, the promoter will select two (2) entries who have provided what the Promoter considers to be the best response to the competition question in the competition post.
